## 投資環境について

### ▶ 債券市況 期間を通じてみると、米国債券市況は上昇しました。

期間の初めから2025年10月頃にかけては、米政府機関の一部閉鎖や米中対立、米地銀の信用不安等を背景に景気減速懸念が強まり、米国金利は低下しました。その後、2026年3月頃にかけては、中東

紛争の長期化懸念を背景にインフレ圧力の高まりが意識され、主要中央銀行の金融政策観測が引き締め方向へ修正されたことから、米国金利が上昇する局面もみられました。期間を通じてみると米国金利は低下し、米国債券市況は金利低下や金利収入の獲得を背景に上昇しました。

## 当該投資信託のポートフォリオについて

### ▶ ピムコ 短期戦略プラス・オープン （為替リスク軽減型）

円建て外国投資信託であるピムコ ショートターム ストラテジー – クラスJ（JPY）およびピムコ バミュダ インカム ファンド A – クラスY（JPY）の投資信託証券への投資を通じて、主として世界（新興国を含みます。）の幅広い種類の公社債等およびそれらの派生商品等を高位に組み入れ、利子収益の確保および値上がり益の獲得をめざす運用を行いました。なお、「PIMCOショートターム戦略」への投資配分を70%、「PIMCOインカム戦略」への投資配分を30%とすることを基本とします。

2026年3月末時点で、2本の円建外国投資信託を通じて投資した信用リスク管理

上、政府機関の発行または保証する有価証券と同等と判断した銘柄の実質的な組入比率は、ファニーメイは5.8%、フレディ・マックは5.1%としました。（ネットベース）

### ▶ ピムコ ショートターム ストラテジー – クラスJ（JPY）

純資産総額を米ドル換算した額とほぼ同額程度の米ドル売り円買いの為替取引を行い、為替変動リスクの低減を図りました。

2026年3月末時点において、金利戦略については、全体の金利リスクを低位に維持しました。債券セクター別では、財務内容の健全性等を慎重に考慮し、リスク対比で投資妙味があると考えられる投資適格社債に投資しました。また、健全性の高い住宅市場の恩恵を受けやすいと考

えられる米非政府系モーゲージ証券にも投資を行っています。新興国債券については、財政状況や対外収支等のファンダメンタルズを精査し、投資対象国を慎重に選別しながら投資判断を継続しています。

ション構築を行う方針としました。

### ▶ ピムコ バミューダ インカム ファンド A - クラスY (JPY)

純資産総額を米ドル換算した額とほぼ同額程度の米ドル売り円買いの為替取引を行い、為替変動リスクの低減を図りました。

2026年3月末時点において、金利戦略については、世界経済の減速に伴う利下げ期待から、主に米国における中期ゾーンのデュレーションを積み増しました。米国以外では、投資妙味の高さから、英国・豪州等も選好しました。

セクター戦略では、引き続きリスク対比で魅力的な利回りとなっている米政府系モーゲージ証券を軸としています。一方でファンダメンタルズが良好な非政府系モーゲージ証券や、強固な財務基盤を持つ規模の大きな金融機関等へも分散投資を行っています。

通貨戦略においては、時折変動が大きいことからリスク量を抑えつつ、魅力的なキャリー収益が期待できる新興国通貨や相対的なバリュエーション等の観点から割安となっている先進国通貨にてポジ

## 今後の運用方針 （作成対象期間末での見解です。）

### ▶ ピムコ 短期戦略プラス・オープン （為替リスク軽減型）

円建て外国投資信託への投資を通じて主として世界（新興国を含みます。）の幅広い種類の公社債等およびそれらの派生商品等を高位に組み入れた運用を行います。なお、「PIMCOショートターム戦略」への投資配分を70%、「PIMCOインカム戦略」への投資配分を30%とすることを基本とします。

### ▶ ピムコ ショートターム ストラテジー － クラスJ（JPY）

運用戦略に関しては、ポートフォリオ全体の金利リスクを低位に抑えつつ、米ドル建ての投資適格債券を中心に信用力の高い銘柄への選別投資を通じて信用リスクを抑制することにより、投資元本の保全と流動性の維持に配慮しながら、着実な収益の獲得を目指す方針です。

純資産総額を米ドル換算した額とほぼ同額程度の米ドル売り円買いの為替取引を行い、為替変動リスクの低減を図ります。

### ▶ ピムコ バミューダ インカム ファンド A － クラスY（JPY）

2026年の世界経済は、AI投資の継続や資産効果等を背景に底堅さが維持される一方、中東情勢に起因するエネルギー供給

ショックにより、成長の下振れリスクとインフレ上振れリスクが同時に意識される見通しです。米国については、財政刺激策や継続的なAI投資等が下支えとなり、底堅い成長が見込まれる一方で、中東情勢に伴うエネルギー供給ショック等を背景に、成長の下振れリスクが高まるとみています。インフレについては、エネルギー価格の上昇を受け短期的には上振れリスクが意識されるものの、世界的な景気減速等を背景に、中期的にはインフレ圧力が緩和に向かう可能性があります。金融政策は、米連邦準備制度理事会（FRB）のインフレに対する警戒感を背景に利下げは後ずれし、2026年に1回、その後2027年に1～2回の利下げを行うと予想しています。ユーロ圏では、防衛費やインフラ投資等の財政出動が一部の国で進む一方、財政余力が限られる国も多く、中東情勢を背景としたエネルギー供給ショックが長期化した場合、成長はより鈍化する可能性があります。インフレ率については、政策金利が既に中立的な水準にある中で、エネルギー価格上昇と成長の減速が併存しており、中央銀行はより難しい政策判断を迫られていると予想しています。かかる環境下、PIMCOインカム戦略としては、世界中の債券に分散投資を行いながら質・流動

性・弁済順位の高さに焦点を当てることで、魅力的な水準のインカム収入を獲得しつつ、中長期的に債券価格の上昇によるキャピタル収入も目指していきます。

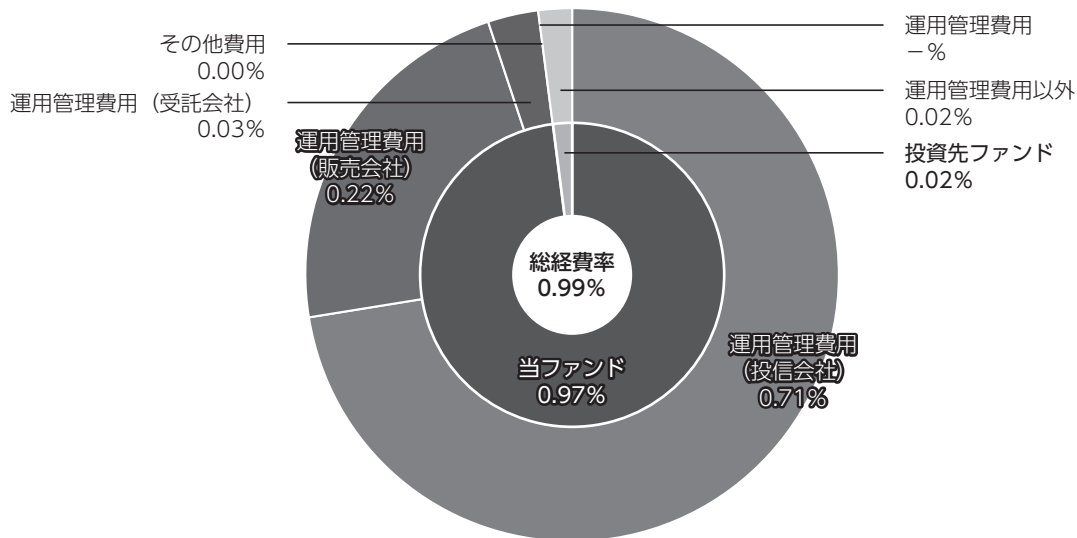
